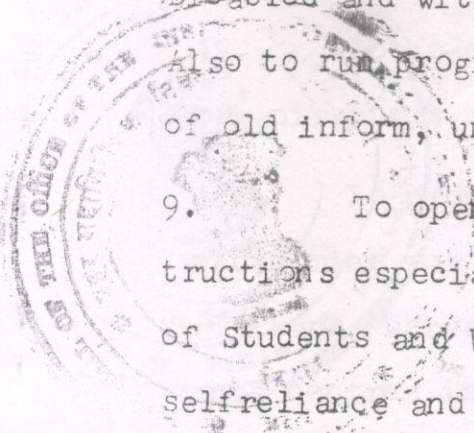

their cultural heritage and to arrange hostel for working women, destitute women girl students etc.

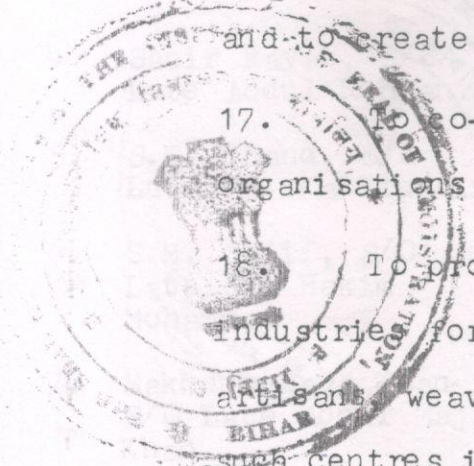

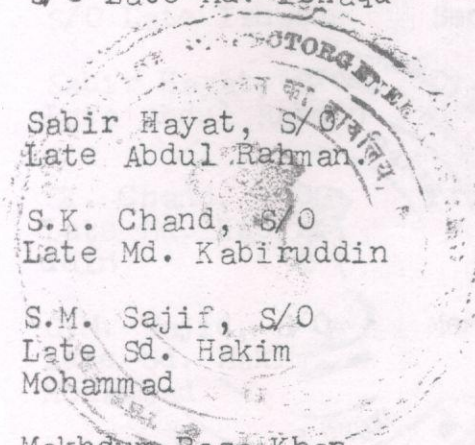

New Era Social Development Welfare Society
Rules and Regulations

1. Definitions:

The following words in these rules shall be defined as per the description mentioned therein.

Society will denote New Era Social Development Welfare Society.

Board of Directors means the Governing Administrative Body of the Society New Era Social Development Welfare Society.

General Body meeting will mean any meeting of active members life member of Board of Directors of New Era Social Development Welfare Society.

'Year' shall mean the financial year starting from 1st April to 31st March.

OFFICE BEARERS:

Shall include Chairman, Vice-Chairman, Secretary, Dy. Secretary and Treasurer.

2. AREA OF ACTIVITY:

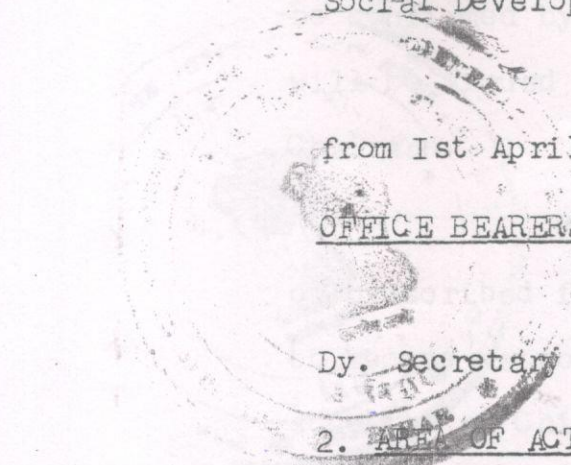
The area of activities of the Society would be all Bihar.

3. MEMBERSHIP:

These agreeing with the objectives of the Society will have three type of membership.

(a) Ordinary Member:

Any male, female, since adult, having faith in the objectives of the Society on payment of membership fee as

(b) Active members:

Adult sane male/female with enjoying trust of the Society can after deposit of the subscription as determined by the Society can be eligible for such membership. Such members could be maximum two from one Panchayat and fifteen from one Prakhand Block.

(c) Life Members:

Sane adult male/femal having faith in the objective or the Society can apply for life membership on payment of subscription of Rs. 2000/- (two Thousand) However it can be revised by Governing Body.

N.B. The membership of all kinds shall however, be confirmed by the governing body only. The admitted members will be issued identity cards by the Society attested by the Chairman.

4. Any distinguished adult, sane personality on payment of prescribed fee of Rs. 10,000/- (Ten Thousand) can be eligible to become patron. The Governing body can adopt any worthy personality as Chief Patron.

5. ADMINISTRATION:

The Governing body will be responsible for control of entire activities and execution of all projects, of the

ATTESTED Society. There will be maximum 19 members, minimum 9 (Nine)

including office bearers Chairman, Vice-Chairman, Secretary, Dy. Secretary.

The election of the office bearers will be held after every five years.

directors would be five years but they can be re-elected.

GENERAL BODY MEETING:

This meeting shall be convened at least once in a year. Deliberation on the following issues will be its business:

- (a) Confirmation of the minutes of the previous meeting.
- (b) Approval of the Annual Report and the Annual Accounts.
- (c) To fill up vacancies of the elected Directors in the Board by the Directors.
- (d) It will approve remunerations, allowances to the Directors.
- (e) Any other matter with the permission of the Chair.

ELECTION:

Every fifth year the vacancies in the board of Directors will be filled in by election. The election will be notified alongwith its dates for fillings, withdrawal and scruting of the nomination papers will be fixed and notified, if there are more nominations than the vacancies there would be election by secret ballot. Such elect one will be conducted by the person nominated appointed by the board of Directors.

The presence of five members will form the quorum for the meeting of the Board of Directors.

The meeting of the Board will be convened once in two months if necessary. The Board Meeting will be called with the permission of the president by the Secretary or acting official in his place may convene the meeting after giving a week's notice. In case of General Body meeting, if necessary it may be convened with the permission of the president giving

convened after giving 24 hours notice.

FUNDS:

- (a) Society funds will be collected from membership fee individual and Government Grants and donations and through fund raising programme.
- (b) In case of requirements and justifications monetary assistance from foreign agencies in a legal way shall also be availed.
- (c) The funds of the Society will be deposited and kept in a bank named by the Board of Directors under the joint operation system. The Society's accounts shall be operated only by any two of the Chairman, Secretary and the treasurer.

Audit of Account:

The Auditor appointed by the Board of Directors will audit the annual account and his report would be placed in the annual general meetings.

General Body meeting/convention the date time and venue will be decided by the Board of Director.

The Board of Directors can appoint committees/sub-Committees for special purposes.

In case of differences in the opinion of the members over the proposal in the meeting of either the Board of Directors or General Body meetings, motion will be decided on the basis of majority by voting. On equal voting by both sides, however, the Chairman shall exercise his casting vote and decide the issue.

Shri Shafi Ahmad would be for 5 years only. However, they can seek re-election.


Vice-Chairman will preside all meetings of the Society in absence of the president, and other works as entrusted by the Chairman.

6. TERMINATION OF MEMBERSHIP:

The membership of the Board of Directors and the general Body will be deemed to have terminated under following circumstances.

(a) Submission of resignation by the member and acceptance by the Board.

(b) Continuous absence of the Director from consecutive three meetings to the Board of Directors, without leaving information without any reasonable cause.

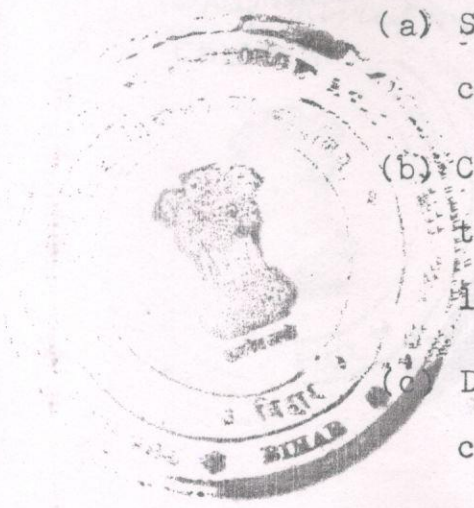
(c) Death or insolvency, in-sanity or conviction for criminal offence.
